While it may require some adjustment of your normal schedule and routine to serve as a juror, we hope that any inconvenience will be minimal.

Please use good judgment and report properly dressed. Shorts, extremely short skirts & tee shirts are inappropriate attire.

We cannot be responsible for personal belongings and suggest that you do not bring expensive articles with you.

COMPENSATION

You will receive \$25.00 for each day that you report to the facility for service. Checks are mailed following your service.
