If the defendant is represented by the Public Defender's Office or a Private attorney:

1. Contact the Public Defender's Office (see number below) or your Private attorney's office to confirm that an "Entry of Appearance" has been filed and that a "Waiver of Arraignment" has been filed.
2. If an "Entry of Appearance" and "Waiver of Arraignment" have not been filed – you are required to attend court. The date, time, and location of your arraignment is located on the attached notice from the clerk's office.
3. Once your attorney properly waives arraignment on your behalf, you are no longer required to appear in person for arraignment. Your case will then be placed on a future calendar, and the clerk's office will mail you and your attorney proper notice of your court date, once it is assigned, to your address on record.

If the defendant does "not" have an attorney:

1. If you do not have an attorney, you **must appear in person** for the arraignment hearing.
2. The date, time, and location of your arraignment is located on the attached notice from the clerk's office.

If the defendant would like to apply for an attorney through the Public Defender's Office:

1. If you would like to apply for an attorney, you will need to contact the Public Defender's Office:

2. If you qualify for a public defender – your attorney may then file a waiver of arraignment on your behalf. Once your attorney properly waives arraignment on your behalf, you are no longer required to appear in person for arraignment. Your case will then be placed on a future calendar, and the clerk's office will mail you and your attorney proper notice of your court date, once it is assigned, to your address on record.
