Counsel are required to be present unless excused by the Court or Uniform Rule 17 applies. If an attorney already has a leave of absence in place for this date, please notify the appropriate solicitor.

At the status calendar, the parties are expected to report the status of each case as follows:

- whether Defendant has been provided all discovery;
- whether there is any discovery issue;
- whether any particularized motion has been filed and/or whether there are any motions that need to be heard by the Court;
- whether there has been a good faith effort to resolve the case;
 - including whether any offer has been communicated from the Solicitor to the defense attorney and from the defense attorney to the client;
- whether your client is requesting a bench trial or a jury trial; and
- whether the case is ready to be placed on a trial calendar.

Pro Se Defendants (Defendants without an attorney) and Defendants represented by an attorney are required to appear. If a defendant fails to appear absent good cause a Bench Warrant will be issued.

If a case is ready for trial, it will be scheduled for the next available trial calendar. Once a trial date is scheduled, no pretrial motions will be heard.

*If a particularized motion has been filed Defendant or Defendant's attorney shall send a copy to opposing counsel and the case will be set for a motions hearing date.
