CRIMINAL STATUS CALENDAR

The cases on the attached calendar will be called for a status on **Thursday, March 30th, 2023, at 9:00 A.M., in Courtroom A, 3rd Floor** at the Carroll County Courthouse. Counsel are required to be present unless excused by the Court or Uniform Rule 17 applies. If any attorney already has a leave of absence in place for this date, please notify the appropriate solicitor.

At the status calendar, the parties are expected to report the status of each case as follows:

- whether Defendant has been provided all discovery;
- whether there is any discovery issue;
- whether any particularized motion has been filed and/or whether there are any motions that need to be heard by the Court;
- whether there has been a good faith effort to resolve the case;
 - including whether any offer has been communicated from the Solicitor to the defense attorney and from the defense attorney to the client;
- whether your client is requesting a bench trial or a jury trial; and
- whether the case is ready to be placed on a trial calendar.

Pro se Defendants (Defendants without an attorney) and Defendants represented by an attorney are required to appear unless a signed Consent Scheduling Order has been agreed upon and sent to opposing counsel prior to March 30th, 2023. A copy of the Consent Scheduling Order form is attached.

A court reporter will not be present at the Status Calendar; therefore, all pleas will need to be scheduled to another date. On the scheduled plea date, both Defendant and his or her attorney must appear. Absent prior excuse by the Court, if a Defendant fails to appear on his or her scheduled plea date, a bench warrant will be issued.

If a case is ready for trial, it will be scheduled on the next available trial date. Once a trial date is scheduled, no pretrial motions will be heard.

The Court will prepare scheduling orders (motion hearing dates and trial dates) during the status calendar for those cases for which a consent Scheduling Order has not already been agreed upon. Once a case is placed on a trial calendar, it will only be removed for good cause shown.

Cases that appear on a status calendar for the second time will not be continued to a future status calendar. Absent good cause shown, the case will be placed on the next available trial calendar.
