If the defendant has an attorney:

Contact your attorney immediately, and set a time to review your case file. The Defendant and their attorney MUST appear for the “Special Calendar”.

If the defendant is represented by the Public Defender’s Office or a Private attorney:

1. Contact the Public Defender’s Office (see number below) or your Private attorney’s office to confirm that an “Entry of Appearance” has been filed.
2. If an “Entry of Appearance” has not been filed – this needs to be filed as soon as possible.

If the defendant does “not” have an attorney:

1. If you do not have an attorney, you **must appear in person** for the “Special Calendar”.

If the defendant would like to apply for an attorney through the Public Defender’s Office:

1. If you would like to apply for an attorney, you will need to contact the Public Defender’s Office:
