Thank you in advance for your understanding and willingness to be flexible as we attempt to comply with the Statewide Judicial Emergency Order and our Coweta Circuit Emergency Judicial Order:

In compliance with the Orders:

The March 18 Carroll Criminal Non Jury calendar is not cancelled but Defendants out on bond shall not appear, they should appear June 3, 2020. Matters concerning inmates will only be brought from the jail with the approval of the Judge. All other cases on the calendar shall be moved to June 3, 2020.

The March 19, 2020 Mental Health court in cancelled.

The March 30 Coweta Civil Non Jury calendar Judge Blackmon will hear essential cases only and Judge Blackmon has issued an Order regarding those cases.

The March 31, 2020 Coweta Civil Trials are cancelled and moved to September 15, 2020 with a Pre-Trial date of August 5, 2020.

The April 1, 2020 Heard Civil Non Jury Calendar Judge Blackmon will hear essential cases only and Judge Blackmon has issued an Order regarding those cases.

The April 15, 2020 Carroll Calendar Call Calendar has been moved to June 2, 2020.
