“Calendar Call” May 2021 Trial Week

Chief Justice Harold D. Melton, on February 7, 2021 signed and filed his “Eleventh Order Extending Declaration of Statewide Judicial Emergence”. Justice Melton’s Order continued the prohibition of jury trials. However, said Order indicated that the prohibition on jury trials is anticipated to be lifted starting in March. See pertinent language from said Order below:

However, the surge in COVID-19 cases that led to the suspension of jury trials appears now to be declining. Assuming that conditions generally continue to improve, it is anticipated that the next extension order on March 9 will authorize superior and state courts, in their discretion, to resume jury trials as local conditions allow.
