Chief Justice Harold D. Melton, on February 7, 2021 signed and filed his "Eleventh Order Extending Declaration of Statewide Judicial Emergence". Justice Melton's Order continued the prohibition of jury trials. However, said Order indicated that the prohibition on jury trials is anticipated to be lifted starting in March. See pertinent language from said Order below:

However, the surge in COVID-19 cases that led to the suspension of jury trials appears now to be declining. Assuming that conditions generally continue to improve, it is anticipated that the next extension order on March 9 will authorize Superior and State courts, in their discretion, to resume jury trials as local conditions allow.

Based on the language in Justice Melton's February 7, 2021 Order, this court is acting proactively in preparing for jury trials. The attached "Calendar Call" is setting a trial calendar for **June 28, 2021.**

The "Calendar Call" SHALL be conducted via ZOOM video

On May 25, 2021 at 9:00 a.m.

Defendants **with** attorneys **do NOT** need to appear.

If the defendant has an attorney:

1. **ZOOM Video:** The Judge's Judicial assistant, Alice Hawkins, will email the ZOOM Video link to all attorneys of record found on the "Calendar Call" calendar.
2. Defense Attorneys and District Attorneys- MUST- contact Alice Hawkins at, ahawkins@carrollcountygga.com, and confirm their email address.
3. Defendants with attorneys do not need to appear.

If the defendant is represented by the Public Defender's Office or a Private attorney:

1. Contact the Public Defender's Office (see number below) or your Private attorney's office to confirm that your attorney has received a copy of this "Calendar Call" notice.
2. Confirm that your attorney has contacted the Judge's judicial assistant to properly sign-up and attend the ZOOM Video "Calendar Call"
3. Defendants with attorneys do not need to appear.

If the defendant does "not" have an attorney:

1. If you do not have an attorney, you **must appear in person** for the arraignment hearing. Because the court is following the Public Health Official's recommendations for "social distancing", the court discourages the defendant from bringing additional family or friends.

Chief Justice Harold D. Melton, on February 7, 2021 signed and filed his "Eleventh Order Extending Declaration of Statewide Judicial Emergence". Justice Melton's Order continued the prohibition of jury trials. However, said Order indicated that the prohibition on jury trials is anticipated to be lifted starting in March. See pertinent language from said Order below:

However, the surge in COVID-19 cases that led to the suspension of jury trials appears now to be declining. Assuming that conditions generally continue to improve, it is anticipated that the next extension order on March 9 will authorize Superior and State courts, in their discretion, to resume jury trials as local conditions allow.

Based on the language in Justice Melton's February 7, 2021 Order, this court is acting proactively in preparing for jury trials. The attached "Calendar Call" is setting a trial calendar for **June 28, 2021.**

Chief Justice Harold D. Melton, on February 7, 2021 signed and filed his "Eleventh Order Extending Declaration of Statewide Judicial Emergency". Justice Melton's Order continued the prohibition of jury trials. However, said Order indicated that the prohibition on jury trials is anticipated to be lifted starting in March. See pertinent language from said Order below:

However, the surge in COVID-19 cases that led to the suspension of jury trials appears now to be declining. Assuming that conditions generally continue to improve, it is anticipated that the next extension order on March 9 will authorize Superior and State courts, in their discretion, to resume jury trials as local conditions allow.

Based on the language in Justice Melton's February 7, 2021 Order, this court is acting proactively in preparing for jury trials. The attached "Calendar Call" is setting a trial calendar for **June 28, 2021.**

The "Calendar Call" SHALL be conducted via ZOOM video

On May 25, 2021 at 9:00 a.m.

Defendants **with** attorneys **do NOT** need to appear.

If the defendant has an attorney:

1. **ZOOM Video:** The Judge's Judicial assistant, Alice Hawkins, will email the ZOOM Video link to all attorneys of record found on the "Calendar Call" calendar.
2. Defense Attorneys and District Attorneys- MUST- contact Alice Hawkins at, ahawkins@carrollcountygga.com, and confirm their email address.
3. Defendants with attorneys do not need to appear.

If the defendant is represented by the Public Defender's Office or a Private attorney:

1. Contact the Public Defender's Office (see number below) or your Private attorney's office to confirm that your attorney has received a copy of this "Calendar Call" notice.
2. Confirm that your attorney has contacted the Judge's judicial assistant to properly sign-up and attend the ZOOM Video "Calendar Call"
3. Defendants with attorneys do not need to appear.

If the defendant does "not" have an attorney:

1. If you do not have an attorney, you **must appear in person** for the arraignment hearing. Because the court is following the Public Health Official's recommendations for "social distancing", the court discourages the defendant from bringing additional family or friends.
